**A RESOLUTION
OF THE KDPW MANAGEMENT BOARD
OF 17 JUNE 2025
ON AMENDMENTS TO RESOLUTION NO. 1081/2024
OF 4 NOVEMBER 2024
ON INDICATING SPECIFIC TIMETABLES OF THE ACCOUNTING DAY
THAT APPLY ON CERTAIN DAYS IN 2025**

On the basis of § 2 subpara. 5, as well as § 9 subpara. 3 of the KDPW Rules, and in connection with the third sentence of § 36 subpara. 2 of the KDPW Detailed Rules of Operation, the KDPW Management Board has resolved the following:

§ 1
