# A RESOLUTION OF THE KDPW MANAGEMENT BOARD OF 27 JUNE 2025

# ON AMENDMENTS TO THE RESOLUTION ON PAYMENTS FROM TRANSACTION SETTLEMENT AND OTHER OPERATIONS PERFORMED BY KDPW AND ON CLEARING BANKS

Acting in accordance with § 23 subpara. 2 of the KDPW Articles of Association and § 2 subparas. 1, 3 and 4 as well as § 4 point 19 of the KDPW Rules, the KDPW Management Board has resolved the following:

§ 1

Resolution No. 617/17 of the KDPW Management Board of 19 September 2017 (as amended) on payments from transaction settlement and other operations performed by KDPW and on clearing banks, shall be amended as follows:

1/ In § 1, subpara. 1 shall be amended as follows:

- "1. Payments in PLN arising from:
- 1) the settlement of transactions or other operations processed by KDPW,
- 2) issuer benefit payments to securities owners,
- shall be processed using the cash current accounts of entities being direct participants of the depository system maintained by the National Bank of Poland as part of the SORBNET3 payment system";

2/ In § 2, subparas. 1 and 2 shall be amended as follows:

- "1. The National Bank of Poland shall be the clearing bank for payments executed in PLN, in accordance with § 4a of the KDPW Rules.
- 2. Bank accounts used to process Euro payments shall be maintained in the TARGET system by central banks that are members of this system.";
